Each year, WRBA holds five dinner meetings where prominent speakers from the political, sports, entertainment and business arenas address the leading businessmen of Richmond. In addition, the August Prospective Member Reception and Texas Hold'Em Tournament, October Boxing Smoker, April Ladies Night and May Annual Golf Tournament & Picnic, promote business fellowship in an informal atmosphere.

Any man qualifying as a current business leader in the Richmond area may be considered for membership. Nominees must be recommended by at least one active Association member and pay an initiation fee of \$125. Corporate initiation fees are transferable for new members replacing prior associates. No initiation fee applies to family members of current members or to multiple members from the same firm. The annual dues of \$375 cover regular monthly dinner meetings, the Prospective Member Reception & Poker Tournament, the Boxing Smoker and the Golf Picnic. There is also a monthly payment plan of \$35 per month (\$420 annually).

The Association's dinner meetings are usually held on the second Monday in the months of September, October, January, February and April.
